NOTIFICATION

Bhota, the 27 January, 2026

No. 2026/908.—In exercise of the powers conferred under Section 125,126,127, 128 read with section 202 and 214 of the Himachal Pradesh Municipal Act, 1994, I, Pankaj Kumar

Secretary, Nagar Panchayat Bhota, Distt.Hamirpur (Himachal Pradesh) hereby notify the following Byelaws (Draft):

1. Short title, Extent and Commencement:

- i. These Bye-laws may be called the Himachal Pradesh Municipality (Grant of Trade License for Trade Activities, Use of Premises and Storage of Articles in a Premises) Byelaws 2025.
- ii. These Bye-Laws shall come into force from the date of their publication in the Official Gazette.
- iii. These Byelaws shall apply to all shops/premises falling within the Municipal limits which may not be used without license for the purpose specified in Section 125, 126, 127, 128 read with section 202 and 214 of the Himachal Pradesh Municipal Act, 1994 as per Annexure-I and for storage of any Article, and performing of any trade within municipal limits as per the Trade Types specified in these byelaws at Annexure-I.

2. Definitions:

In these Byelaws, unless the context otherwise requires:

- (a) "Act" means the Himachal Pradesh Municipal Act,1994, (Act No. 12 of 1994)
- (b) "Authorized Officer" means Secretary or any other Officer specifically authorized by the Secretary.
- (c) Urban Local Body (ULB): An Urban Local Body (ULB) is an administrative unit in urban areas, responsible for governance, management and development. ULBs for this byelaw is categorized into Nagar Panchayat Bhota.
- (d) "Inspector" means Sanitary Inspector or any other Official of the Nagar Panchayat Bhota duly authorized by the Secretary.
- (e) "License" means a written permission granted by the Secretary or any other official/Officer duly authorized by the Secretary in favor of the person, owner & occupier for sale/storage of articles and Trade Types specified in Annexure I, and zones as per Annexure II of these Byelaws.
- (f) "Licensing Officer" means Secretary or any other officer duly authorized by the Secretary to grant/ renew License under the provisions of these Byelaws.
- (g) "premises", means any shop/store/place where the articles specified in Annexure I are kept for sale/storage in the godown/ premises and or where the trade activities as specified under Annexure I are performed.
- (h) "Small Scale Business/Trade" means premises covering maximum area of 300 sq. ft. "Medium Scale Business/Trade" means premises covering area more than of 300 sq. ft. to 500 sq. ft. and "large Scale Business/Trade" means premises covering area of more than 500 Sq. ft.

- (i) **Small Shop:** A shop covering an area upto 300 square ft. shall be deemed to be a small shop.
- (j) **Medium Shop:** A shop covering an area more than 300 sq. ft. and upto 500 square ft. shall be deemed to be a medium shop.
- (k) **Large Shop:** A shop covering an area more than 500 square ft. shall be deemed to be a large shop.
- (l) **Temporary Trade License:** This license is issued for a brief period ranging from 1 to 30 days. It is applicable exclusively to trade activities conducted from temporary, or makeshift shops or stalls at approved fairs, events, etc. It is mandatory for the fair organizer/ temporary shop or stall owner to get the individual temporary trade license as per the terms defined in this byelaw.
- (m) **Zone:** Functional boundary of the ULB, area designated for specific types of trade activities.
- (n) **Superstore:** typically refers to a large retail establishment that sells a wide variety of goods.
- (o) **E-commerce:** Electronic commerce, refers to the buying and selling of goods and services over the internet. It encompasses a wide range of online business activities for products and services.
- (p) **Cloud Kitchen:** A cloud kitchen, also known as a virtual kitchen, is a type of commercial kitchen space dedicated solely to preparing food for delivery and takeout.
- (q) **Municipal Services:** include but not limited to Garbage Collection, Property Tax, Electricity supply, Water supply and Sewerage connection, provided under the jurisdiction of the Nagar Panchayat which can be regulated by separate authorities.
- (r) “Shopkeeper” means any person running and managing the affairs of the shop/premises/place including its owner/occupier.
- (s) The words and expression not defined under these Byelaws shall have the same meaning or sense as are defined in Himachal Pradesh Municipal Act, 1994.

3. Procedure for Obtaining License:

- (a) Any person who wants to operate/run any business/trade as specified in Annexure I and/ or store any article as specified in Annexure I within the areas of the Nagar Panchayat Bhota and as per zone definitions in Annexure II shall apply for license on prescribed Format to Nagar Panchayat Bhota.
- (b) **Period of License:** The License shall be issued for a period of 1year, 5 Years, 10 years & maximum upto fifteen years at a time and the License shall automatically come to an end after completion of such period.

4. Renewal of License:

- (i) The license will be automatically renewed upon expiration once the applicant deposits the required fee. It can be renewed without any late fee or additional documentation within one month after expiration. If renewed within the following month (2nd Month of Expiry), a 50% penalty will apply. Beyond this period, the license cannot be renewed, and a new trade license must be applied.
- (ii) No document is required to be submitted for renewal of License

5. Transfer of License:

- (i) The license issued under the Byelaws shall not be transferred in the name of any person except in case of the death of original licensee wherein it shall be made/ transferred in the name of the legal heirs only for the validity period of license on production of supporting documents and shall be decided by Secretary keeping in view the circumstances of the case.
- (ii) Transfer of Trade License fees will be charged as per prescribed fees decided by the ULB.

6. Closure of License:

The license issued under the byelaws can be requested for closure in case of winding up of the business. The licensee shall provide information as per prescribed guidelines to the Secretary for winding up of his business. Closure of Trade License fees will be charged as per prescribed fees, decided by the ULB.

7. Modification of License:

The license issued under the byelaws can be requested for modification in the following heads only:

- (i) In-case of Change of Mobile Number (Trade Owner)
- (ii) In-case of Change and/or Addition in Sub-category or Trade under the pre-selected sector as per Annexure I. (Note: Sector cannot be Modified, Multiple licenses will have to be applied for, multiple sectors.
- (iii) In-case of Change of Business/ Trade Address (Modification of trade address is only allowed in case the address is being changed within the same ward of the ULB).

Modification of Trade License fees will be charged as per prescribed fees, decided by the ULB.

8. License Fees:

The license fee for grant of license shall be decided by the **Secretary** from time to time. The fee shall be charged in the following manner:

9. Temporary Trade Licenses:

- (i) Temporary Trade Licenses are applicable only in case of fairs, festivals, and other such events within the ULB, for a period of 1 day to 30 days only.
- (ii) These licenses are specifically issued for temporary or makeshift shops or stalls at fairs and similar events. Temporary Trade License Fees to be charged as per the formula below:

10. Temporary Permissions:

11. Conditions for Grant of License:

- i. Trade registration with the Labour & Employment Department, Government of Himachal Pradesh, is a mandatory prerequisite for applying for a Trade License from Urban Local Bodies (ULBs).
- ii. The License shall not be valid for any other purpose, except for the items/articles for which it is granted under these Bye Laws.
- iii. The permission shall, unless specified otherwise in the license, be valid in the entire NP Bhota limits, subject to such conditions as may be imposed by the Secretary.
- iv. The owner /occupier of the premises shall have to produce the license before the Inspector or the licensing officer at any point of time as may be ordered by them.
- v. The Secretary shall have a right to impose or alter any of conditions in the license as may be deemed fit by him/her under the provisions of Section 214 of the Himachal Pradesh Municipal Act, 1994.
- vi. Additional Permissions for any article/ trade mentioned in annexure I may be added by the Secretary as and when deemed necessary.
- vii. The applicant shall submit a self-declaration regarding information submitted by him / her about the premises to be used for business/ trade *viz.* type of business, area, approval of map and nature of property *i.e* commercial and domestic etc. to be true to the best of his knowledge and belief.
- viii. The licensee shall maintain proper record of the articles kept for sale or storage and trade activities being performed in the premises as may be required by the Licensing Officer. Further the licensee shall comply with all the directions and instructions issued to him by the Secretary or the Licensing Officer from time to time.
- ix. The licensee will ensure timely payment of Municipal dues.
- x. Time period for issue of License: The license shall be issued as per the timelines notified/specified for this service under Public Service Guarantee Act, 2011.
- xi. Subject to these Byelaws, license to any person, who applies online to the Secretary or Licensing Officer in this behalf and tenders the prescribed fee shall be granted by that officer, unless for reasons to be recorded in writing by him.
- xii. The Licensee shall be liable to pay transfer, modification, closure charges as prescribed by ULB per license at the time of effecting transfer of License, modification of license, closure of license.
- xiii. The licensee shall abide by the terms and conditions of the license and the license shall be displayed at the convenient/ conspicuous place /reception of the premises.
- xiv. The Inspector or inspecting staff concerned shall have a right to enter and inspect the premises and the licensee shall provide necessary assistance to the inspecting staff at the time of inspection of licensed premises.
- xv. The licensee shall not make any encroachment/ overhanging projection on public streets and Municipal drains in any manner.

12. Denials of License:

- (1) The license shall not be granted:
 - i. to a person suffering from any loathsome infections or contagious diseases.
 - ii. to a person convicted for unlawful sale or storage of any articles mentioned in Section 125,126,127, 128 read with section 202 and 214 of the Himachal Pradesh Municipal Act, 1994.
 - iii. to a person who has been found to have habitually committed the breach of these Bye- Laws or the terms of the license.
 - iv. to a person not below the age of 18 years.

13. Offenses and Penalties:

- (i) In addition to the penalty as provided under Himachal Pradesh Municipal Act, 1994 any person in possession of the premises found violating any of the provisions of these Byelaws shall in the first instance be liable for a penalty of Rs. 500/- only and suspension of license for a period of one month and for repetition of the same violation within three months be liable for penalty of Rs. 5000/- only and permanent Cancellation/withdrawal of license.
- (ii) If the information submitted by the applicant under self-declaration is found to be false, he/she shall be liable for the penalty of ten times of the license fee and his/her license will be cancelled.
- (iii) In case of repeated violations, the concerned person, owner or occupier, as the case shall be liable for cancellation/withdrawal of License which can only be restored on receiving written undertaking accompanied by surety from the person violating these Bye-laws subject to the satisfaction of the Commissioner/ Executive Officer/ Secretary.

14. Penalization for Default on Municipal Services:

In the interest of maintaining compliance and to ensure the seamless provision of municipal services, the Nagar Panchayat Bhota hereby enacts the following:—

- 1. Interlinked Service Compliance.**—All Municipal Services, including but not limited to Garbage Collection, Property Tax, Electricity, Water, and Sewerage, provided under the jurisdiction of the Nagar Panchayat Bhota and regulated by separate authorities, shall be interlinked for compliance purposes.
- 2. Cross- Service Penalization.**—Any resident or entity found to be in violation of the regulations pertaining to any one of the municipal services shall be subject to cross-municipal service penalization. This includes but is not limited to:
 - i. Suspension or limitation of other municipal services
 - ii. Imposition of additional fines and penalties across all utilities
 - iii. Notification and reporting of violations across regulatory authorities for coordinated enforcement.
- 3. Repercussions for Trade License service.**—Municipal Service Defaulters will not be allowed to apply/ renew/ modify/ close trade licenses till the violation is resolved.

4. **Notification and Appeal.**—Prior to the enforcement of cross-municipal penalties, the affected party shall receive a written notice detailing the nature of the violation, the affected services, and the penalties to be imposed.

The affected party shall have the right to appeal against the penalization within a stipulated period as prescribed by the Nagar Panchayat Bhota.

5. **Inter-Authority Coordination.**—Regulatory authorities governing each municipal service shall establish a coordination mechanism to ensure the efficient and timely exchange of information regarding violations and enforcement actions.

Regular meetings shall be held between regulatory authorities to review compliance status and address issues related to cross-municipal service penalization.

15. Zone Categorization:

Nagar Panchayat Bhota should consider categorizing trade license fees within their respective ULBs based on the zone in which the trading unit is located. Zones can be defined as outlined in Annexure II.

These Byelaws shall come into effect immediately upon its inclusion in the Nagar Panchayat Bhota Byelaws. The Municipality shall periodically review and update the cross-municipal penalization framework to address emerging challenges and ensure fair and effective enforcement.
