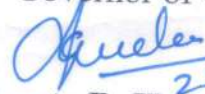
NOTIFICATION

In pursuance to sub section (1) of Section 40A of the Goa Panchayat Raj Act, 1994 (Goa Act No.14 of 1994), the Government of Goa hereby declares **Sunday, the 8th March, 2026 (Phalguna 17, Saka 1947) as a “Paid Holiday” being the “Polling Day”** for the Bye Election to Ward No.I of Village Panchayat Chandel-Hasapur, Ward No.IV of Village Panchayat Mandrem, Ward No.VII of Village Panchayat Piligao, Ward No.III of Village Panchayat Latambarcem, Ward No.I of Village Panchayat Pilerne Marna, Ward No.VI of Village Panchayat Sirsaim, Ward No.II of Village Panchayat Salvador Do Mundo, Ward No.I of Village Panchayat Candolim, Ward No.VI of Village Panchayat Aquem Baixo, Ward No.I of Village Panchayat Borim, Ward No.III of Village Panchayat Veling-Priol-Cuncoliem, Ward No.III of Village Panchayat Bhoma Adcolna, Ward No.VIII of Village Panchayat Balli Adnem and Ward No.VIII of Village Panchayat Loliem Polem, **to every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at the aforesaid Bye Election, throughout the State of Goa.**

The aforesaid holiday shall be a **“paid holiday”**, in addition to the holidays indicated in the Notification No.37/3/2025-GAD-III/4171 dated 30/09/2025 published in the Official Gazette, Series II No.28, dated 09/10/2025 read with Corrigendum No.37/8/2025-GAD-III/4282 dated 07/10/2025 and shall also be applicable as such to the following persons who are entitled to vote at the aforesaid Bye Election:-

- (i) workers of all establishments including commercial and industrial undertakings in the State of Goa;
- (ii) daily wage/casual workers employed in any business, trade, industrial undertakings, Government departments, State Government Industrial Departments or any other establishment.
