ORDER:

In accordance with the Election Schedule issued by the Telangana State Election Commission vide reference 1st cited, the **2nd Ordinary Elections to Gram Panchayats-2025** will be held in **Phase-I, Phase-II and Phase-III** in Sangareddy District on the dates noted below:

- 1) **Phase - I : 11.12.2025**
- 2) **Phase - II : 14.12.2025**
- 3) **Phase - III : 17.12.2025**

In this regard, as per the powers delegated under G.O.Ms.No.54, PR & RD (PTS.III) Dept., dated 03.07.2015, the District Collector & District Election Authority is competent to declare a Local Holiday / Public Holiday in the local areas notified for elections on the poll day to enable every eligible voter to exercise his/her franchise freely.

Accordingly, the District Collector & District Election Authority, Sangareddy hereby declares a Local Holiday / Public Holiday on the poll days 11.12.2025, 14.12.2025 and 17.12.2025, applicable only to the poll-bound areas under the respective phases, for the following categories:

- 1) Government Offices, Local Bodies, and Government Institutions located in the polling areas. This includes areas notified on the day preceding the day of poll to be used for election related activities.
- 2) Public Sector Undertakings, Educational Institutions (Government/Aided/Private), and all Public & Private Establishments situated in the poll-bound areas.
- 3) Central Government employees, who are bonafide voters in the poll-bound areas, are permitted limited time-off (late attendance / early leaving / short absence) subject to exigencies of service.

- 4) The poll day is also declared as a Public Holiday under the provisions of the Negotiable Instruments Act / Shops & Establishments Act in the respective areas.
- 5) All Heads of Offices, Institutions, Establishments and Employers in the poll-bound areas shall ensure strict compliance with these orders.


These orders are issued in the interest of ensuring free, fair and peaceful elections.
