G.S.R.14 .-Whereas, the draft of the Rajasthan Rights of Persons with Disabilities (Draft Amendment) Rules, 2025 was published in the Rajasthan Gazette extraordinary part 4 (ga) up-khand (I) dated 24.07.2025 inviting objections and suggestions from all persons likely to be affected thereby;

And whereas, State Government is of the opinion that promotional benefit shall be granted on a notional basis from 30.06.2016 upto the commencement of these amendment rules. Hence following revised draft rules are hereby published for information of all persons likely to be affected thereby;

Now therefore, the following draft rules, which the State Government proposes to make in exercise of the powers conferred by sub-section (1) of section 101 of the Rights of Persons with Disabilities Act, 2016 (Central Act No. 49 of 2016), for the information of all the persons likely to be affected thereby and notice is hereby given to them that the said draft rules shall be taken into consideration after the expiry of a period of seven days from the date on which the copies of this notification as published in the Official Gazette are made available to the public;

Any objection or suggestion which may be received from any person with respect to the said draft rules before the expiry of the period specified above will be considered by the State Government. Such objection or suggestion should be addressed to the Director, Special Aabled Persons, G-3/1-A, VisheshYogyajan Bhawan, Behind Rajmahal Hotel, Jaipur (Rajasthan) or by email at dir.dsap@rajasthan.gov.in.

DRAFT RULES

- 1. Short title and commencement.**-(1) These rules may be called the Rajasthan Rights of Persons with Disabilities (Draft) (Amendment) Rules, 2026.
(2) They shall come into force from the date of their final publication in the Official Gazette.

2. Amendment of rule 5.- The existing second proviso to sub-rule (1) of rule 5 of the Rajasthan Rights of Persons with Disabilities Rules, 2018 shall be substituted by the following, namely:-

"Provided further that the reservation in promotion, with effect from 30.06.2016, shall be in accordance with such instructions as may be issued by the State Government, from time to time. The promotional benefits under this provision shall be granted on a notional basis from 30.06.2016 upto the date of commencement of the Rajasthan Rights of Persons with Disabilities (Amendment) Rules, 2026. Any person who was promoted prior to the commencement of the Rajasthan Rights of Persons with Disabilities (Amendment) Rules, 2026, shall not be reverted on account of the promotion of a person with disability from an earlier year. In case where number of persons promoted exceeds the number of sanctioned posts, the administrative department may create shadow post with the concurrence of the Finance Department."
