The following Bills were introduced in Lok Sabha on 11th August, 2025:—

BILL No. 104 OF 2025

A Bill to consolidate and amend the law relating to income-tax.

BE it enacted by Parliament in the Seventy-sixth Year of the Republic of India,
as follows:—

CHAPTER I

PRELIMINARY

- (1) This Act may be called the Income-tax (No. 2) Act, 2025.
- (2) It extends to the whole of India.
- (3) Save as otherwise provided in this Act, it shall come into force on the 1st April, 2026.

BILL No. 105 OF 2025

A Bill further to amend the Income-tax Act, 1961 and to amend the Finance Act, 2025.

BE it enacted by Parliament in the Seventy-sixth Year of the Republic of India as follows:—

CHAPTER I

PRELIMINARY

1. This Act may be called the Taxation Laws (Amendment) Act, 2025.
