## ORDER

In exercise of the powers conferred by the Delhi Epidemic Diseases, COVID-19, Regulations, 2020 under the Epidemic Diseases Act, 1897, the following directions are hereby issued for the purpose of prevention and control of the outbreak of epidemic disease namely COVID-19 in NCT of Delhi, with immediate effect:

- (i) All Restaurants in NCT of Delhi shall discontinue sitting arrangements in their premises till 31<sup>st</sup> March, 2020. However, the operations of Home Delivery and Take Away from the Restaurants could be continued.
- (ii) All Sports complexes in NCT of Delhi shall be closed till 31st March, 2020.
- (iii) Any event (Social/Cultural/Political/Religious/Academic/Sports/Seminar and Conference (except marriages) is restricted to maximum of 20 persons instead of 50 persons in NCT of Delhi till 31<sup>st</sup> March, 2020.
