ORDER

Under Section 144 of the Code of Criminal Procedure of 1973

WHEREAS, there is a prevailing situation in the Country due to the Health Emergency posed by COVID-19, an infectious disease caused by Corona Virus;

AND WHEREAS, in order to contain the spread of the said epidemic, certain measures are required to be taken;

AND WHEREAS, the Public Health Department, Government of Goa vide Notification No.23/20/2014-I/PHD/Part IV/552 dated 13/03/2020 had declared the Coronavirus disease (COVID-19) and HINI disease to be notifiable disease for the purposes of Part II of Chapter VII of the Public Health Act, 1985 throughout the State of Goa;

AND WHEREAS, it is essential to enforce social distancing of people to prevent the spread of the disease;

AND WHEREAS, in view of this, it is necessary to take exigent measures in this regards so as to prevent any danger to human life or safety, to thwart the spread of virus, which may affect the overall security of the State and may create 11, so sturbance of larger public order and tranquillity;

F'NOW, THEREFORE, I, Ajit Roy, IAS, District Magistrate, South Goa, Margao, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure,1973, do hereby prohibit all concerned in South Goa District from the following:

(a) Assembly and gathering of four or more persons and taking out or organizing of processions.

- (b) Taking out any procession or staging any demonstration on the road, street or thoroughfare.
- (c) Holding any public meeting.

Any person contravening this Order shall be liable for punishment under Section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned, the Order is hereby passed ex-parte.

The Order shall come into force with immediate effect and shall remain in force till further orders.

AND WHEREAS, the Public Health Department, Government of Goa vide Notification No.23/20/2014-I/PHD/Part IV/552 dated 13/03/2020 had declared the Coronavirus disease (COVID-19) and HINI disease to be notifiable disease for the purposes of Part II of Chapter VII of the Public Health Act, 1985 throughout the State of Goa:

AND WHEREAS, the State Government has taken various measures to contain the spread of Coronavirus;

AND WHEREAS, it is noticed that there are many rumours spread in Society through mass and social media without its proper verification and also there are instances of some misreporting in the newspapers which has lead to doubts and panic in the Society which has potential of likely incitement to violence or threat to public safety and potential danger for maintenance of normal law and water society;

NOW, THEREFORE, I, Ajit Roy, IAS, District Magistrate, South Goa, Margao, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure, 1973, do hereby prohibit all concerned from spreading any kind of rumours, misreporting, and/or any kind of misinformation through social media, electronic media, print media or spread by word of mouth or in any form which may result in any kind of breach of law and order and/or may lead to unrest in Society;

Any person contravening this Order shall be liable for punishment under Section 188 of the Indian Penal Code.

As the notice cannot be served individually on all concerned, the Order is hereby passed ex-parte.

The Order shall come into force with immediate effect and shall remain in force till further orders.

AND WHEREAS, the Public Health Department, Government of Goa vide Notification No.23/20/2014-I/PHD/Part IV/552 dated 13/03/2020 had declared the Coronavirus disease (COVID-19) and HINI disease to be notifiable disease for the purposes of Part II of Chapter VII of the Public Health Act, 1985 throughout the State of Goa;

AND WHEREAS, the State Government has taken various measures to prevent the occurrence and spread;

AND WHEREAS, some stringent measures are required to be taken to ban the movement of passenger vehicles - Maxicab(12+1), all heavy Passenger vehicles like contract carriage, stage carriage, All India Tourist Buses (Tourist Omni Buses) plying from the State of Karnataka and Maharashtra into South Goa District and from South Goa District to Karnataka and Maharashtra State with immediate effect until further orders as per "The Goa Epidemic Disease, COVID-19 Regulations, 2020" to contain the spread of COVID-19 disease in South Goa District;

NOW, THEREFORE, I, Ajit Roy, IAS, District Magistrate, South Goa, Margao, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure, 1973, read with "The Goa Epidemic Disease, COVID-19 Regulations, 2020" do hereby direct and prohibit/ban the movement of Passenger vehicles Maxicub (12+1), All Heavy Passenger Vehicles like Contract Carriage,

Stage Carriage, All India Tourist Buses (Tourist Omni Buses) plying from State of Karnataka and Maharashtra into South Goa District and from South Goa District to Karnataka and Maharashtra State with immediate effect until further orders from midnight of 21st March, 2020.

Any person contravening this Order shall be liable for punishment under Section 188 of the Indian Penal Code,

As the notice cannot be served individually on all concerned, the Order is hereby passed ex-parte.

The Order shall come into force with immediate effect and shall remain in force till further orders.
